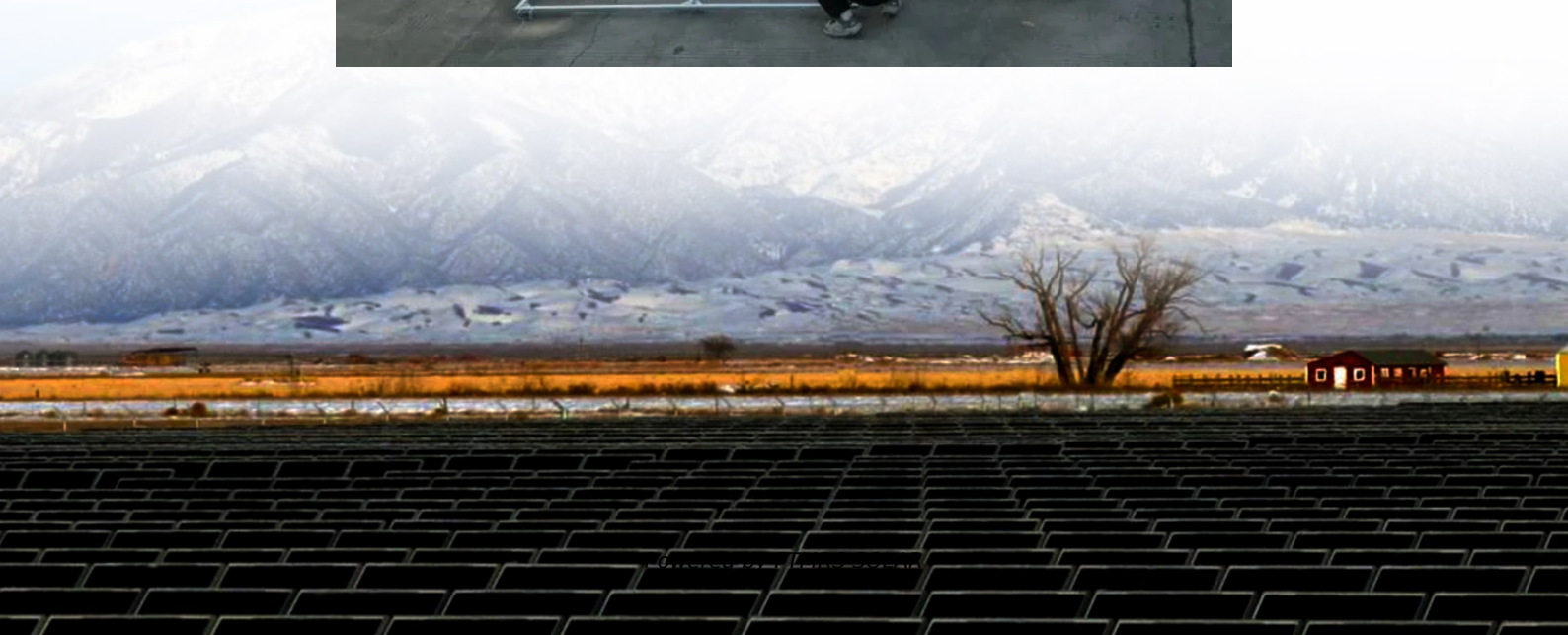


Angola solar container battery import tariffs





Overview

What's new in Angola's customs tariff?

Tell us and we will take a look. Presidential Legislative Decree no 1/24 outlined the revision in Angola's customs tariff of import and export duties to support Angola's production sector. The change in import tariff rates are applicable to most originating products in the HS chapters.

How much are import duties in Angola?

Import duties are currently on average 10.9 percent with a range from 2 to 50 percent. A World Trade Organization (WTO) analysis of Angola's custom tariffs shows that import duties on agriculture and non-agricultural products were on average 19.3 percent and 8.7 percent respectively.

What is the tariff rate in Angola?

Tariffs are taxes imposed on imported goods and services. Currently, the tariff rate for 15% applies to imports from Angola. This represents additional costs that importers pay when bringing goods into the United States from Angola. Furthermore, this rate can change based on trade agreements, economic conditions, and government policies.

How to import from Angola?

Importing from Angola requires proper customs declarations, country of origin documentation, HS code classifications, and payment of the 15% tariff rate along with any other applicable duties and taxes. We are also working on building a comprehensive database of HS code classifications & a more comprehensive list of documentation requirements.
