How should a chemical container be stored?

Read a chemical's MSDS/SDS for proper storage procedures. Do not store glass chemical containers on the floor (without secondary containment) or window ledges. Chemical storage areas should be well lit, appropriately ventilated and kept away from aisles, exits, and heat. Minimize storage.

Where should hazardous materials be stored?

Hazardous materials must be stored in containers designed specifically for the substance they contain. For instance, flammable liquids should be kept in fireproof containers, while chemicals that react with moisture should be stored in moisture-resistant containers.

Are You storing hazardous chemicals in bulk?

You are storing a hazardous chemical in bulk if it's in: an undivided quantity over 500 kg, if the chemical is a solid. You must put a placard on these containers in line with WHS Regulations. Secure bulk containers and any pipe work or attachments to foundations and supports so they're stable and don't move.
