

Overview

Does India export photovoltaic modules?

The export of Indian photovoltaic (PV) modules has risen exponentially by more than 23 times between Fiscal Year (FY) 2022 and FY2024, primarily to the US, which accounted for more than 97% of India's exports in both FY2023 and FY2024.

Which countries import the most solar modules in 2024?

From January to December 2024, China exported 10.57 GW of modules to Spain, down 10% YoY from 11.75 GW, accounting for 11% of the Europe's total, while the Netherlands led with a 40% share. The Asia-Pacific imported 4.56 GW of modules from China in December 2024, down 10% MoM from 5.08 GW and down 30% YoY from 6.56 GW.

Following is a simple SLD to showcase how Zero Export works in a solar PV system. To be able to do the zero export, we need a zero export meter [bi-directional meter] on the incoming side. This meter should be MODBUS RTU enabled so that our Power Control device can communicate with it to read the ACTIVE POWER values.
