


# **Financing Scheme for High-Temperature Resistant Photovoltaic Containers in Eastern Europe**

Europe relies on solar photovoltaic (PV) as one of the main energy sources in its climate roadmap. Europe has been a pioneer and leader in PV production, and the installation targets are continually increasing via Renewable Energy Directive revisions.

What is the European Solar charter?

To this end, the European Solar Charter sets out immediate actions to be taken by the Commission, EU Member States and the representatives of the solar PV value chain, in particular wholesale, distribution and manufacturing parts, to be implemented ensuring full compliance with EU competition law and state aid rules.

How does ESIA support solar PV production in Europe?

ESIA also supports clear and harmonised non-price criteria that reward best-performing solar systems based on sustainability and resilience criteria as a key tool for financing solar PV production in Europe.

Can the EU build its energy future on PV products?

The European Union (EU) is not willing to build its energy future on products without ensuring their continued reliability and availability. One of the main enablers, a pillar of the US strategy of the Inflation Reduction Act (IRA), is to reshore a strategic share of PV manufacturing capacities.
