### How much are Solomon Islands goods worth?

Solomon Islands Consumer goods imports are worth US\$ 317 million, product share of 52.73%. Solomon Islands Capital goods exports are worth US\$ 2 million, product share of 0.30%. Solomon Islands Capital goods imports are worth US\$ 189 million, product share of 31.44%.
