Are energy storage codes & standards needed?

Does industry need standards for energy storage?

As cited in the DOE OE ES Program Plan, "Industry requires specifications of standards for characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry professionals indicate a significant need for standards . " [1, p. 30].

What is a battery management standard?

It includes use in several application areas, including stationary batteries installed in local energy storage, smart grids and auxiliary power systems, as well as mobile batteries used in electric vehicles (EV), rail transport and aeronautics.
